

THE TITLE OF THE ARTICLE

A. A. First, University or Place of employment, Town, Country, E-mail of the first author,

B. B. Second, University or Place of employment, Town, Country, E-mail of the second author,
etc.

The abstract by the authors (annotation) is a brief resume of the full article. It can be published separately from basic text and hence should be clear without reference to the original article. The recommended size of annotation is about 120-250 words. The annotation should include the following aspects of the content of the article: 1. subject, topic and object of the article; 2. methods or methodology of the work; 3. results of the work; 4. sphere of application of the results of work; 5. conclusion. The annotation should contain the scientific content of the article, information about the problem under solution, methods of solution, results and conclusion. It shouldn't have figures, formulae, bibliography and sources of financing as well as references. Diagrams, formulae, charts, figures, schemes are not accepted. The text of annotations should use the syntax of scientific and technical documents, complex grammatical structures are unacceptable.)

Keywords: key words (up to 5 words or expressions), the key words or expressions should be separated by commas.

Introduction

The editorial board recommends authors to follow the guidelines and samples of articles when submitting them for publication. The articles which do not meet the requirements are not considered by the editorial board. The article should be typed with the use of text editor "LaTeX" according to the example (*see sample.tex*), using of stylesheet *jecm.sty*. Each article should have the following information:

- last name, first name, middle name of the author (in full);
- work position of the author (if any);
- contact details (mail address; e-mail);
- the title of the article;
- annotation (120-250 words, formula and the list of references are not included);
- key words (up to 5 words or expressions), the key words or expressions should be separated by commas;
- Universal decimal classification codes;
- MSC codes.

Periodical includes the following sections: -Survey Articles, -Computational Mathematics, -Engineering Mathematics, -Short Notes, -Personalia.

The section "Survey Articles" contains review articles in the field of publication. The section "Short Notes" contains reports by postgraduate students and masters in the field of publication. The section "Personalia" contains biographical articles about outstanding scientists. The size of the original articles shouldn't exceed 12 pages in the sections "Computational Mathematics" and "Engineering Mathematics" as for the "Survey Articles" they shouldn't exceed 24 pages. The size of the "Short Notes" shouldn't exceed 5 pages.

It is necessary to follow the rules:

Numbering of formulae. It is necessary to use continuous numbering of formulae, theorems, lemmas, derived relations and derivations. It is desirable to mark all the formulae (the number is given in the right-hand margin of the basic text and enclosed in round brackets), but it is acceptable to mark only those mentioned in the text. Interpretation of symbols used in formulae is given in order of their use in formulae.

Figures. It is recommended to use black and white figures with resolution of 300-600 dpi (eps format). Figures are given in addition to the article in the form of separate files (use the techniques of lossless data compression) as it will economize the time of preprocess.

Diagrams. Above the diagram "Diagram" should be written (right-margin aligning). The diagram should be included without paragraph indentation. All diagrams in the text should have reference.




Fig. 1. Graph of the numerical solution of smth.

2. Second

At the end of the article a list of references and bibliographic reference are to be given. Here should be the sources which the author makes reference to. Reference to the quoted sources in the text are to be given in the form of numbers corresponding to the number of the article in the list of references enclosed in square brackets. Sample of reference to the quoted sources [1, Theorem 4.1], [3, 4]. Reference to unpublished articles is prohibited.
